If I apply to any service or product electronically through BML Internet Banking or BML Mobile Banking, the Bank will consider such application as originating from myself and as a legally valid application. If such an application is approved by the Bank, I agree to be bound by the Terms and Conditions governing the use of such product or service;
7. Acknowledge that if I have Credit/Debit/Prepaid Card(s) issued by Bank of Maldives, I will be able to access these Card account(s) and the Bank account(s) through BML Internet Banking or BML Mobile Banking. I agree that the use of these accounts are also subject to BML Debit Card Terms & Conditions / BML Credit Card Terms & Conditions/ BML Prepaid Card Terms & Conditions and Terms & Conditions of the respective product;
8. Acknowledge that functions of BML Internet Banking or BML Mobile Banking are conducted by myself acting alone, no provision exists for joint operation other than the Authoriser and Initiator functions referred to in the BML Online Banking terms and conditions;
