HOW DO I REGISTER?

You have to be a Bank of Maldives Customer to register for Maldives Internet Banking services. All you have to do is complete the Maldives Internet Banking Application Form and submit it to any of our Branches (except BML Lite) or Bank of Maldives Card Centre.

HOW DO I GET MY LOGIN DETAILS?

Once your application is processed, we will send a temporary User ID to your mobile via SMS and your temporary Password will be sent to your E-mail address. Please change it as soon as possible.

WHAT ARE THE CHARGES?

There is no connection fee, monthly fee or an annual fee for Maldives Internet Banking. However if you choose to receive one-time Passwords via Security Token, you can purchase one from BML Card Centre for a fee of MVR200/-. However charges for individual transactions apply. Kindly refer to Bank of Maldives Schedule of Charges for more details.



It is Easy, Flexible, Gives you Control

BillPAY is a free service of Maldives Internet Banking that allows you to pay your bills online.

Through Maldives Internet Banking you can make payments 24 hours a day, 7 days a week. When you register for Maldives Internet Banking you will be automatically registered for the BillPAY service.

Bank of Maldives has established relationships with a number of service providers. You can choose from these service providers, whom you wish to include in your payee list. Once you have created your payee list, you can immediately start paying bills or schedule your payments. For scheduled payments, you can receive advance notification. You can also make payments from ATMs to the billers you have added to your payee list.

IMPORTANT INFORMATION
1. If you are a Company/Organisation/Firm, a Maldives Internet Banking Function and Limit Access Request must be completed for each Nominee and submitted with this form. A Board Resolution and copy of Memorandum and Articles of Association, a copy of business registration along with the latest share transfer form must also be submitted. Sample copy of the Board Resolution is available to download from the bank's website.
2. In the case of a Joint Account/Partnership Account all parties must sign. The Maldives Internet Banking Application form has to be completed separately for each individual Joint Account Holder/Partner to get access to joint Accounts / Partnership Accounts through Maldives Internet Banking.
3. Maldives Internet Banking access is not available for Minor accounts.



DECLARATION

This declaration is made to Bank of Maldives Plc. By signing below I/we agree to the following:

1. To subscribe to a service of the Bank known as Maldives Internet Banking according to the Terms and Conditions of use set by Bank of Maldives Plc from time to time and of which I/we am/are aware and agree to be bound;
2. Acknowledge that the Bank may rely and act upon any use of the User ID and Password with regard to the access authorised for a particular User ID;
3. Confirm that I/we am/are the sole account holder(s) or have required mandate to operate all the accounts which shall be linked to Maldives Internet Banking;
4. Acknowledge that any account authority the account holder may have with the Bank now or in the future and any amendments or cancellation thereto will not affect this Internet Banking authority which is to continue in full force and effect until the Bank receives notice of amendment or cancellation, and that in providing access to Maldives Internet Banking the Bank is not required to have regard to any account authority other than this Internet Banking Authority;
5. Acknowledge that if I/we have Debit or Credit Card(s) issued by Bank of Maldives Plc, I/we will be able to access these Credit Card account(s) and the Bank account(s) linked to the Debit Card(s) through Maldives Internet Banking, and I/we will also be able to access the current/savings account(s) linked to Maldives Internet Banking through my/our Debit or Credit Card(s); and I/we agree that the use of these accounts are also subject to the Bank of Maldives Debit / Credit Cardholder Agreements;
6. Acknowledge that if I/we apply for any Bank of Maldives Debit Card, Credit Card, or any other product or service electronically through my/our Maldives Internet Banking access, the Bank will consider such application as originating from me/us and as legally valid; and if such application is approved by the Bank and the requested card, product or service is offered to and accepted by me/us, the Terms and Conditions governing the use of such respective card, product, or service will be valid and binding upon me/us.
7. Acknowledge that functions of Maldives Internet Banking are conducted by a person acting alone, no provision exists for joint operation other than the Authoriser and Initiator functions referred to in the Internet Banking terms and conditions;
8. I/We acknowledge that, Bank of Maldives PLC will not be liable for any losses incurred due to misuse of communications sent to your registered Mobile Number and/or Email Address provided to the Bank or due to change of any said details without prior written notice to the Bank.
9. Consent to disclosure of my/our personal information to joint account holders or, where applicable, Nominees, when they view my/our statement of account; and
10. Where we are a company, organization or a firm,
 - (a) Authorise the Bank to provide access to Internet Banking to the Nominees listed on the Maldives Internet Banking Function and Limit Access Authority Request. The account holder will advise the Bank of any change to the Nominees and the permitted Access;
 - (b) Understand that the Password will only be issued by the Bank to the nominated Nominee and that the Nominee may change the Password.

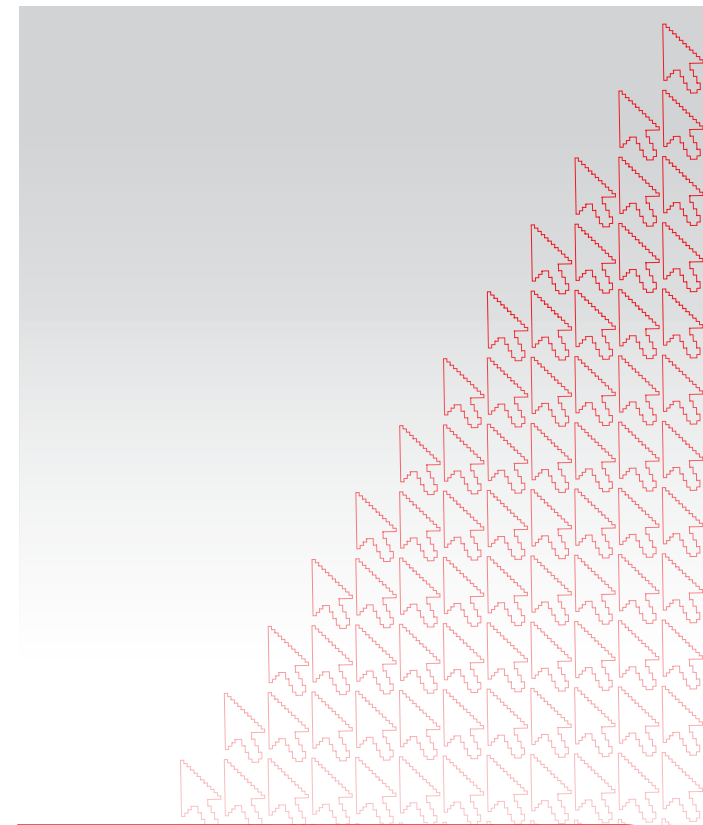
